**Comments:**

As Chair of Frisby Village Hall Committee I fully support the Neighbourhood Plans. It is obvious a lot of time and effort has been spent to ensure it represents the vast majority of Frisby residents. The need to restrict the growth of Frisby is so important. The inevitability of additional housing in Frisby will definitely cause traffic problems. Already the infrequent bus service through Water Lane has difficulty with parked cars. During Village Hall events when outside visitors arrive there are 6 parking spaces at the hall and the rest find places wherever they can. There is a need for a car park.

I assume that with the new houses there will be Section 106. The Frisby Village Hall Committee would like to stress the need for finance towards a new floor and ceiling/roof on the existing hall and would ideally like to build an extension at the back of the hall with a raised ceiling to accommodate Badminton and other sporting activities. The sum of £100k has been calculated to cover this.

Meanwhile I hope the MBC are able to approve our Neighbourhood plan and ensure it is considered in future planning applications.

I fully support the Neighbourhood Plan. I believe it to be a professional and detailed plan. It recognises the need to keep Frisby as a small village, which is why I chose to live here. Frisby has few facilities but has a "good neighbour feel" and the reason to live in a village rather than a town with all the town amenities. The lack of public transport is a problem and with a 2 hourly bus service which finishes early evening and none on Sunday means that any idea of visiting Melton, Leicester or Nottingham for an evening event involves cars or taxis . With ageing it will mean limited evening and weekend entertainment but I still love village life in Frisby and the groups who run the clubs mean that the need to venture further afield makes transport less of a problem.

I hope that the new housing will provide bungalows for the elderly rather than affordable social housing as anyone living and working in Frisby must have a car to get to work and I cannot see how anyone without a job could cope here.
