It is critical that new development is steered away from areas at risk of flooding - whether this be surface water, groundwater, or river floodwaters. The appropriate testing should be carried out to identify sites which are not suitable - the Sequential Test being crucial to this assessment. There has been too much development on areas at risk of flooding, nationwide, and we now have to ensure that in every city, town and village, only appropriate development takes place. There are too many occasions where new developments flaunt the aims of the NPPF with regard to flooding. I want to feel comfortable that any new development that takes place in our village, does so with the full agreement of the EA, the LLFA, and I want to know that a sequential test has been carried out, properly, in all cases where there is a proposal for new build in Flood Zone 2 or 3.
