#### Comments:

FRIS2 is an important area of land for the dissipation of surface water from a large catchment area that runs up to the A607 (including FRIS3). It is labelled "Essential Washland" in the outgoing Melton Local Plan. It also has a very high water table that rapidly rises and falls with the river levels. It is also only two fields away from the Frisby Marsh SSSI and is likely to play a significant part, along with the river, in maintaining the water levels and water quality upon which the SSSI depends. Also, traffic along Water Lane is restricted by resident parking by the lovely old terraced cottages at one end and the level crossing (adjacent to the site FRIS2) and I have attached some photographs of traffic on Water Lane that exemplify current day-to-day problems and also flooding on Water Lane and Wellfield Lane. \*The document containing the photographs will not upload to the server. I will send separately by email\*

FRIS3 has known drainage issues and contributes to flood problems in the lower part of the village (and FRIS2). Part of it is on a very steep slope and new housing there would be overbearing on existing houses on Hall Orchard/Oak/Ash Way and the school itself. Traffic safety would be a particularly insurmountable problem as the proposed access to the development is from a single track lane which also provides the only pedestrian route to the (dangerous) bus stops on the A607. Cars joining the A607 from this lane with great difficulty due to the speed of traffic on the road and poor visibility (bends in the road). It is dangerous to join the A607 from this junction and so traffic will have to flow through the entire village to use safer junctions.
