This clause to the policy should be deleted as any developer has the right in law to connect to the foul sewage network and it is up to the provider (in this case Severn Trent) to ensure there is sufficient capacity.

Therefore the occupation of the development cannot be restricted by capacity as the provider must ensure there is capacity in the network.
