Frisby is classified as a Rural Hub. It is a small rural village with history dating back to medieval times. I believe it would be wholly inappropriate for it to be considered a service centre, despite the views of developers who care only for money and profit. There are already two service centres in close proximity. The overwhelming majority of villagers want Frisby to remain a rural village, in line with the Localism Bill, this should be respected. The village clearly does not have the infrastructure to sustain a service centre.

Personally, I strongly disagree that the village requires 78 new dwellings. I have objected to all of the proposed sites. However it is clear that MBC are intent on this and so the Neighbourhood Plan should support the local plan. I very reluctantly accept this.

In order to maintain older more historic part of the village (Main Street / Water Lane) and not to add more development sites than absolutely necessary, building on one site well away from the village centre will cause the least disruption to villagers. With that in mind I agree with the proposed limits to development as specified in the neighbourhood plan.

In summary, the Neighbourhood Plan is a very well written document which I fully support.
