## INTRODUCTION

### What is this document?

This document sets out a limited number of focused changes to the Pre Submission draft Local Plan. Taken together, the Pre-submission Draft Local Plan and the Addendum of Focused Changes is what the Council wishes to submit to the Government for examination as its submission draft local plan.

### Who has prepared it and why has it been prepared?

This document has been prepared by Melton Borough Council. The focused changes proposed are to reflect and respond to new, updated or revised technical studies and information received during or after the consultation on the Pre Submission Draft Local Plan. In doing so, they also respond to many of the representations made about the draft local plan around these themes.

These focused changes are necessary for soundness and/or legal compliance on the main issues that the local plan seeks to address, namely:

1. Setting a housing requirement that meets the Borough's own housing needs, supports its economic ambitions and meets any unmet housing needs arising from elsewhere in the HMA;
2. Identifying an achievable portfolio of sufficient suitable and sustainable housing land which will provide a deliverable five year

supply of housing land and meet the Boroughs housing requirement;

3. Delivering affordable housing;
4. Meeting the accommodation needs of Gypsies, Travellers and Travelling Showpeople; and
5. Delivering the Melton Mowbray Transport Strategy, in particular its key component, the Melton Mowbray Distributor Road

The main new items of information or evidence on which these focused changes rely are referenced at the appropriate point in this document and its appendices and are all available to view on [www.meltonplan.gov.uk](http://www.meltonplan.gov.uk) alongside this document.

Within its scope, the focused changes also respond to specific detailed information provided in consultation responses or ongoing dialogue with statutory bodies such as Leicestershire County Council (as the local education authority and local highways and transportation authority), the Environment Agency, Historic England, and utility companies, such as Severn Trent.

The Council does not consider that these focused changes result in a change to the plan's strategy, rather that they give clarity, realism and further detail on how, where, when and by whom the key components of that strategy will be delivered. Their publication does not preclude further modifications that could be suggested by the Council and others up to and during the Public Examination into the Melton Local Plan, or be recommended by a Local Plan Inspector in due course.
